	Dhanu and Debra explained the dental program which provides sealants to second grade students at 15 elementary schools. Dental sealants help prevent and stop decay. Parental consent is required. Over 400 students received the service last school year. The program began in 2015 with a seed grant. Sealant retention checks are conducted the following year. Marketplace Open Enrollment- Anne Packham, Marketplace Project Director, Primary Care Access Network

Anne shared that open enrollment begins on November 1st and ends December 15th. The shortened enrollment is just one of the challenges they are facing. Another challenge is confusion of the law by the general public. Many think that it has been repealed but currently everything is still in place. Anne also caution against web pages that may contain misleading information regarding ACA. Individuals can call the hotline 1-877-564-5031 to check eligibility for insurance and subsidies. Seminole County Public Schools Dining Services – Richard Miles, MS,RD Coordinator of Nutrition and Wellness

Richard shared the following information:

- For the first time SCPS took the lead on coordinating hurricane shelters.
- Emergency Feeding Program Meals were provided to students at Midway and Casselberry during the week school was closed due to the hurricane.
- Following Hurricane Irma, breakfast and lunch are being provided at no charge for all students from 9/18/17 to 10/20/17.
- A Wellness Champion is to be selected at school and worksites to serve as a liaison between staff and students at their location and the district's wellness team. They will form a wellness committee and will promote, plan and implement a wellness program. Some funding will be available for adult wellness activities.
- Insider SCPS is an online platform available to share wellness information and events for staff and staff families.

Open Forum School Health Services Audit- Gigi Rivadeneyra and Patty Caulfield Gigi and Patty shared that the Florida Department of Health will be conducting Health Services and clinic audits at four schools. This will take place October 2-4th. State audits are conducted every two years. On alternate years, audits are conducted by the Department of Health in Seminole Count y and Seminole County Public Schools School Health personnel. DOH team thanked SCPS dining services, transportation and school nurses for their hard work and dedicated service during Hurricane Irma's special needs shelter activation. Nurses were very much in need and Patty Caulfield and Barbara Davenport volunteered to provide nursing support at special needs shelters. **Round Robin** Martha Santoni shared that Nemours will be doing an Autism Screening Day Monday, October 30th at the Department of Health in Seminole County for children up to age 6 years old. Katherine Beltran from The YMCA opened their doors to the public to use their facility showers and congregating air conditioned areas following Hurricane Irma. • Gigi shared that there will be a Suicide Prevention Training (QPR) and Resource Fair on October 6th at the Florida Department of Health in Seminole County. Debbie Caudill shared that Healthy Schools, LLC will be providing flu vaccines again this year for students. This year's registration has been online as opposed to previous paper forms and there have been reported difficulties for parents signing up. This could be an explanation for the reason of low numbers signed up so far.

Freddie Nieves stated that the Seminole County Public Schools Crisis Team has been called upon on numerous occasions already this school year. The
